Hebrews 11

Together, the numbers 11, 12, and 13 immediately bring to mind two different scenarios. The first is the Masters golf course in Augusta and its famed challenging holes, numbers 11-13 universally known as, “Amen Corner”. Those historic holes derived their name stemming from a Sports Illustrated reporter’s description of Arnold Palmer’s 1958 victory.

I’m believing that one day soon I’ll be able to actually play the course and navigate holes 11, 12, and 13 myself in par or better. I get nervous just thinking about teeing the ball up on the short, but perilous par 3 - number 12. Water, azalea bushes, sand traps and general mayhem smilingly await any deviation of a perfect stroke (deviation of which I’m fully capable!).

Both concepts – getting on the course to play, and then playing well, are pretty remote for anyone. For instance, the waiting list to become a member at the esteemed Augusta course hasn’t changed since 1972. Thousands of ‘wanna be’ members have lined up for more than 30 years, money in hand, but no openings. Just to attend the event for one day is only \$800.00 for a week day or \$850.00 for a single Saturday or Sunday if you buy your ticket this week. Those prices will go up in days. Very few people I know have played Augusta, but all card-carrying hackers would drop what we’re doing immediately if (when) the chance arises to play Augusta!

The other scenario that comes to mind for me if you were to say those three numbers together is found in the Bible in Hebrews 11, 12, and 13. These ending chapters of this incredible book have some of the most memorable passages you’ll ever read. All three start with powerful statements that are relevant for every reader in any century. For instance, Hebrews 11, verse 1 says, “Now faith is being sure of what we hope for and certain of what we do not see.”

STOP! Hold on a minute. Now there’s an AMEN!!! Chapter 11 goes on to highlight several renowned men and women of God and how they lived “by faith”. These Saints held to the promises that God gave them even though they never saw the promise become reality during their lifetime. The author of Hebrews mentions Abel, Enoch, Noah, Abraham, Isaac, Jacob, Joseph, Moses, Rahab, Gideon, Barak, Samson, Jephtha, David, Samuel and the prophets – to name a few – and speaks of how they lived – BY FAITH!

Without seeing, without full knowledge, without details, yet fully trusting, fully believing and acting on God’s word and direction in their lives, they lived each day “by faith”.

What’s even more amazing is that they walked “by faith” without ever seeing or ever acquiring God’s promises in their lifetime.

“These were all commended for their faith, yet none of them received what had been promised. God had planned something better for us so that only together with us would they be made

perfect.” Hebrews 11:39-40 Another resounding “Amen”! The promise occurred, but not during their lifetime. The promise was delivered, but was not seen. The reward was heavenly and not earthly, and therefore much greater than they could ever have imagined!

Did you know that God has something better planned for us? The writer of Hebrews is talking about the Saints, including himself, when he says, “God had planned something better for us”. I know in my heart of hearts that He is including me in that “us”. And if you are a believer in Christ, walking “By Faith”, then you are included in the term “us”, as well. God has something much better planned for us – and that means you, my friend! God’s plan for you and those who live “by faith” is the perfect plan, the most empowered plan, indeed the optimal and only plan, much better than we can even contemplate.

Regardless of what we are going through right now; regardless of not being able to see the fulfilled promise, we walk by faith, knowing that a better plan is in place for our inheritance. We refuse to bow down at the altar of d.o.u.b.t, oh no! We bow down at the altar of Almighty God, moving forward “by faith”.

I have no question that every one of the Saints mentioned in Hebrews 11 was ridiculed for their “by faith” approach to life. There is no question that they were called derisive names, “stupid”, “gullible”, and much worse. Furthermore, the writer details much greater persecutions, including being tortured and “sawed in half”.

I know personally that they experienced all kind of ridicule, because I get it every day. Proclaim your faith in Jesus in a public forum and see what happens! Hardly a day passes that I’m not accosted in print (newspaper, e-mails, blogs, etc.) by someone proclaiming how bad a person I am or how stupid I am for doing what I do, especially proclaiming the name of Jesus in the marketplace.

They can rant and rave all they want to, because what I’m doing is simply trusting God’s direction in business, humbly carrying His directives out.
