unlawful purpose, for example, by suggesting how it might be concealed. A lawyer may not continue assisting a client in conduct that the lawyer originally supposes is legally proper but then discovers is criminal or fraudulent. Withdrawal from the representation, therefore, may be required.....Withdrawal is also justified if the client persists in a course of action that the lawyer reasonably believes is criminal or fraudulent, for a lawyer is not required to be associated with such conduct.....

a lawyer shall not knowingly:

- (a) make a false statement of material fact or law to a third person; or
- (b) fail to disclose a material fact to a third person when disclosure is necessary to avoid making the lawyer a party to a criminal act or knowingly assisting a fraudulent act

Rule 8.04 Misconduct

- (a) A lawyer shall not:
 - (2) commit a serious crime or commit any other criminal act that reflects adversely on the lawyers honesty, trustworthiness or fitness as a lawyer in other respects;
 - (3) engage in conduct involving dishonesty, fraud, deceit or misrepresentation;.....

Kidman needs to address these issues immediately before a lengthy file ends up in the Dallas office of the Chief Disciplinary Counsel.

1. The court papers clearly show that Tim Darnell/ Advantage Conferences lost when Judge Mary Murphy granted the Better Business Bureau's Motion for Summary Judgment. Timmy was forced to pay by means of a Writ of Garnishment.

2. You mention clients/customers, but AC has none of those. That is what generates serious questions of legality and causes the 98% loss rate.

5. Since you are for the moment a licensed attorney and should be fairly astute you could also take a crack at the questions I posed for Jack, since he isn't capable of providing any facts.
