It's like an exciting expedition into adventure, into risky business! And it is critical like every thing else that goes with everlasting success. Inner space exploration is truly the only way to hear Him speak. He choses to speak to us spirit to Spirit and if we are not sensitive to His voice, we will miss out on the greatest adventure of our lives. The Creator of the cosmos actually chooses to speak to us! All we have to do, as you know, is to invite the Holy Spirit of Christ to dwell in us, making Him our personal God and Lord.

Hard to imagine the Almighty God choosing us as His dwelling place now, instead of a glorious

temple of gold and precious jewels like in Soloman's time. How in the world can I be the Holy of Holies? And yet I am, if I believe scripture and I do. What a fascinating journey inner space exploration is when the spirit of each of us, one person at a time, is made alive in Christ, and therefore tuned in to the Holy Spirit of God.

May the supernatural favor of God you mentioned continue to make you bold, my friend, because if we do not continue to share the truth about Him for the sake of others, who will?

I'm looking forward to reading more as you boldly go where few have gone before!
