You sound as if you are admitting to charity fraud, lad. The work done is quite commendable and I applaud those who have given their time and money. You are totally misreading my posts. You are having reading comprehension problems again.

Our family has spent thousands reaching out to former reps you defrauded. We knew it wouldn't be tax deductible. Your charity debacle is based on lies and deceit. The status and nature of the entity was totally misrepresented in order to solicit donations.

If you were matching donations and gave thousands or tens of thousands of dollars, don't tell us you didn't deduct it on your federal taxes. I am sure the plaintiff as a donor will request those records and your annual tax returns for 2005-2007. IRS audit here you come.

That charity Timmy set up without his church's blessing or knowledge is just a way to fraudulently collect money and use it as he pleases with no active board of directors, control by the church or reasonable oversight. One of the 3 board members hadn't spoken to Tim in 2 years as of this April.

It is a relationship of parent and affiliate/auxiliary the church won't recognize and as a result the IRS probably won't recognize either. Timmy said all along that it was a federally recognized (the IRS is the only federal agency that has that in its mandate) 501 (c) (3). He knew full well it wasn't. The Texas Non Profit Corporation Act does not give an entity tax deductible contributions either. That again is the IRS.

Churches don't have to register to have that status, but if they are large umbrella organizations and have auxiliaries many will register so everything is covered under a group letter. The IRS made it clear that Treasures must follow the written guidlines I published. Let's review a few salient points we should be discussing.

Texas Non-Profit Corporation Act says:
Quote:

All records, books, and annual reports of the financial activity of the corporation shall be kept at the registered office or principal office of the corporation in this state for at least three years after the closing of each fiscal year and shall be available to the public for inspection and copying there during normal business hours.

Do you and Timmy have the books available for public inspection and copying as required by law?

The IRS says: Quote:

- be described both as an IRC section 501(c)(3) charitable organization and as a public charity under IRC sections 509(a)(1), (2), or (3),
- be affiliated with a church or convention or association of churches, and
- receive financial support primarily from internal church sources as opposed to public or governmental sources.

How do you explain that when it is obvious the church is not associated with scammer Tim and is not treating the foundation as required? The church's website has never mentioned TFK and if one calls they have no clue what foundation one is talking about.

The IRS also says:

Quote:

IRS Approval of Exemption Application

If the application for tax-exempt status is approved, the IRS will notify the organization of its status, any requirement to file an annual information return, and its eligibility to receive deductible contributions. The IRS does not assign a special number or other identification as evidence of an organization's tax-exempt status.

Tell us what you know about those requirements and how AC is fulfilling them.

In addition the IRS says:

Quote:

Churches and religious organizations, like many other charitable organizations, qualify for exemption from federal income tax under IRC section 501(c)(3) and are generally eligible to receive tax-deductible contributions....

Quote:

Church Exemption Through a Central/Parent Organization A church with a parent organization may wish to contact the parent to see if it has a group ruling. If the parent holds a group ruling, then the IRS may already recognize the church as tax exempt. Under the group exemption process, the parent organization becomes the holder of a group ruling that identifies other affiliated churches or other affiliated organizations. A church is recognized as tax exempt if it is included in a list provided by the parent organization. The parent is then required to submit an annual group exemption update to the IRS in which it provides additions, deletions, and changes within the group. If the church or other affiliated organization is included on such a list, it does not need to take further action to obtain recognition of tax-exempt status. An organization that is not covered under a group ruling should contact its parent organization to see if it is eligible to be included in the parent's application for the group ruling. For general information on the group exemption process, see Revenue Procedure 80-27, 1980-1 C.B. 677.

Where is Timmy's letter showing he is part of a group ruling?

Furthermore the IRS says: Quote:

- (h) Integrated auxiliary—(1) In general. For purposes of this title, the term integrated auxiliary of a church means an organization that is—
- (i) Described both in sections 501(c)(3) and 509(a) (1), (2), or (3);
- (ii) Affiliated with a church or a convention or association of churches; and
- (iii) **Internally supported**. (receive financial support primarily from internal church sources)
- (2) Affiliation. An organization is affiliated with a church or a convention or association of churches, for purposes of paragraph (h)(1)(ii) of this section, if—
- (i) **The organization is covered by a group exemption letter** issued under applicable administrative procedures, (such as Rev. Proc. 80–27 (1980–1 C.B. 677); See §601.601(a)(2)(ii)(b)), to a church or a convention or association of churches;
- (ii) The organization is operated, supervised, or controlled by or in connection with (as defined in §1.509(a)-4) a church or a convention or association of churches; or
- (iii) Relevant facts and circumstances show that it is so affiliated.
- (3) Facts and circumstances. For purposes of paragraph (h)(2)(iii) of this section, relevant facts and circumstances that indicate an organization is affiliated with a church or a convention or

association of churches include the following factors. However, the absence of one or more of the following factors does not necessarily preclude classification of an organization as being affiliated with a church or a convention or association of churches—

- (i) The organization's enabling instrument (corporate charter, trust instrument, articles of association, constitution or similar document) or by-laws affirm that the organization shares common religious doctrines, principles, disciplines, or practices with a church or a convention or association of churches:
- (ii) A church or a convention or association of churches has the authority to appoint or remove, or to control the appointment or removal of, at least one of the organization's officers or directors:
- (iii) The corporate name of the organization indicates an institutional relationship with a church or a convention or association of churches;
- (iv) The organization reports at least annually on its financial and general operations to a church or a convention or association of churches;
- (v) An institutional relationship between the organization and a church or a convention or association of churches is **affirmed** by the church, or convention or association of churches, or a designee thereof; and
- (vi) In the event of dissolution, the organization's assets are required to be distributed to a church or a convention or association of churches, or to an affiliate thereof within the meaning of this paragraph (h).
- (4) Internal support. An organization is internally supported, for purposes of paragraph (h)(1)(iii) of this section, unless it both—

"You have heard it said, 'Love your neighbor and hate your enemy.' But I tell you: Love your enemies and pray for those who persecute you, that you may be sons of your Father in heaven." Matthew 5:43-44a

In the sixties, we often heard, "Jesus is the answer." My fun-loving Puerto Rican friend, Frankie, would always comment, "I know Jesus is the answer, but what is the question," and everybody would laugh.

Here's an example of one of those important questions (of many) for you and me and the entire world, "how is the hatred and war in the Middle East ever going to be resolved?" Quite assuredly, the answer is that that situation can and will only be resolved when it is answered correctly – through Jesus Christ. He is the "way, the truth, and the life" John 14:6a and anytime that crucial, elemental understanding is rejected, then chaos ensues.

All records, books, and annual reports of the financial activity of the corporation shall be kept at the registered office or principal office of the corporation in this state for at least three years after the closing of each fiscal year and shall be available to the public for inspection and copying there during normal business hours.

I suspect that those are not ready for me to copy as you haven't posted anything about those records.

- 3. The IRS says Treasures must be affiliated with a church or convention or association of churches. Timmy just made that claim for he first time on April 11, 2008.
- 4. The IRS states the integrated auxiliary must receive financial support primarily from internal church sources as opposed to public or governmental sources. Timmy has produced nothing to show that anyone other than his beleaguered reps has ever donated to his little foundation.
- 5. The IRS maintains that under the group exemption process the parent organization or church becomes the holder of a group ruling that identifies other affiliated churches or other affiliated organizations....The organization is covered by a group exemption letter issued under applicable administrative procedures, (such as Rev. Proc. 80–27 (1980–1 C.B. 677); See §601.601(a)(2)(ii)(b)), to a church or a convention or association of churches.

- 7. Does the church have any members on the board? Does the church have any say in who is

appointed to the charity's board?

- 8. TFK's name certainly doesn't reflect the relationship Timmy claims with his church.
- 9. Timmy should be reporting annually according to the IRS or monthly according to his church's website. Post those documents, Jack.
- 10. The relationship of auxiliary/integrated charity and parent/church should be affirmed by the church. We see no evidence of that. The church members I spoke with said there was no sanctioned auxiliary, it has never appeared on the church's website and the office staff has no knowledge of any Treasures for the Kingdom Foundation.

Are you boys going to now claim that the church could be under the umbrella of the Southern Baptist Convention of Texas, which is registered with the IRS as tax deductible and tax-exempt? Will you goofs claim TFK is under the Collin Baptist Association that is not registered as I suspect it is under the umbrella of the Texas group? Make a tree good and its fruit will be good, or make a tree bad and its fruit will be bad, for a tree is recognized by its fruit. You brood of vipers, how can you who are evil say anything good? For out of the overflow of the heart, the mouth speaks. The good man brings good things out of the good stored up in him, and the evil man brings evil things out of the evil stored up in him. The goal is to develop a new understanding that blends current findings on business excellence and entrepreneurship with a Christian perspective. A couple references for you to look up after the call are: Ephesians 2:8-10; John 15:16a; 1 Cor. 12: 12-18.

## Positioned by God

The Bible places much emphasis on spiritual gifts. Christian Entrepreneurs believe that one of their gifts is the specific position in which the Lord has placed them. By birth, by education, by training, or by circumstance, the Entrepreneur has an opportunity to create some sort of business enterprise which meets the needs of people. Christian Entrepreneurs are not blindly driven by ambition and greed, but in fact, feel called by the Lord to perform certain tasks and achieve certain goals in their business enterprises. References: John 15:16b; 1 Corinthians 12:18.

## Visionary

Because of the position in which the Lord has placed them, Christian Entrepreneurs develop a specific vision of the future - the way things could or should be for customers, suppliers, employees, family and community. Over a period of time, this vision creates a very strong commitment which weathers countless set-backs and adversities. Through the Lord, the Christian Entrepreneur becomes empowered by this vision. Although their motives are often misunderstood, dedication to the unfolding truth of their vision as revealed by God is the guiding premise of their labor. References: Romans 1:1-14; 2 Cor. 4:1, 6: 4-10; Gal. 6:9-10.

### Calculated Risk Taker

The Christian Entrepreneur believes that life is not for the faint hearted. Modern business requires that major commitments be made. Generally, there isn't sufficient information available in order to totally justify decisions. Therefore, the Christian Entrepreneur must become a calculated risk taker. There is significant Biblical foundation for taking risks. The Christian Entrepreneur is drawn to a life of adventure in service, but recognizes that the price of the adventure will be occasional failure and set-backs. References: Genesis 12: 1-12; Acts 21:13-14.

## Servant Leadership Provides Value to Customers

The Christian Entrepreneur of the 2000's recognizes that the world has changed as mass customization, the Internet and globalization have taken new ideas and rapidly moved them into practice across the world. The prerequisites for business success have changed dramatically. In the new economy, the Christian model of service correlates well with the requirements for achieving business success. Today's Customer requires dedication in all of the little things, as

well as a constantly evolving desire for innovation, quality and cost-effective products and services. Christian Entrepreneurs are called to a life of serving customers through the realization of their vision. References: John 13:7-20.

# Relational Leadership

This is no longer a Horatio Alger world. Gone are the days in which a single entrepreneur can make it on his own over time. This is true because the world so quickly adapts and copies new innovations and ideas. It isn't the entrepreneur against the world, it is the entrepreneur involving a group of committed individuals to embrace the vision in order to constantly bring new value to the customer. In order to get committed employee/partners, Christian entrepreneurs must put their personal relationship with them near the top. The Christian Entrepreneur cannot be everything for everyone, but must build a highly focused organization which serves a few customer groups very well. Entrepreneurs build networks of people while everyone else looks for work. References: Philippians 2:1-29.

### In the World, But Not of It

When is enough, enough? The world often characterizes entrepreneurs as crass materialists. The Christian Entrepreneur gratefully receives and acknowledges material blessings which may come with successfully developing a business; however, material goals are always secondary to the primary calling and vision. Financial success has a way of contaminating the Vision. The Christian Entrepreneur constantly seeks out strength from above to stay willing to "lay it on the line" for the vision. The Christian Entrepreneur will refuse to be drawn into the materialistic world in which we live. With this commitment, a strong moral character is developed over time. Integrity is no guarantee of worldly success, in fact it often works against it; but without integrity, the prize is worthless. References: 1 Cor. 9:19-26; Acts 20:33-35; Philippians 3:7-15; 1 Timothy 6:5-12.

Now, that we have some foundational principles for Christian entrepreneurs, I want to continue this call with some basics regarding success and then get into the challenges and problems that each of us face, and more importantly, how to overcome them...not according to the world, but according to the Word.

Success is a choice. Failure is also a choice. When you understand God's promises for your life as a Believer, the purpose of wealth and the lives we can reach, there is nothing that can stand in your way....at least not for very long.

- ....And maybe I am the only one that has ever dealt with some of these limited thoughts, well, here are 5 key thoughts that most of us deal with at various times.
- 1. The first thought of defeat: You Can't Do It. The root that empowers: Philippians 4:13: I can do all things through Christ that strengthens me; I CAN DO IT!
- 2. Second thought: You Have the Wrong Motive. The thought comes to you 'You just want to be blessed because you're selfish. Who do you think you are? God says He wants me blessed! God calls me blessed, so that I can be a blessing.

- 3. Third thought: You're not worthy –you don't deserve to be blessed. Look at all the mistakes you made; you don't deserve it. You say, I'm not worthy through my works; I am worthy through the BLOOD of Jesus. I do deserve it (not through my works) but through grace and because God is a good God.
- 4. Fourth thought: It's not going to happen for you. It doesn't work for everybody Well, He did it for Abraham, Isaac, and Jacob, and so He's got to do it for you. God is no respecter of persons and He says whosoever believes shall have what they say, and I'm one of those whosoevers who believes! Amen?
- 5. The Fifth thought: It's Too Late. You can't recover. Look at how much ground you've lost. Everybody is ahead of you. BALONEY. You say NO! He that began a good work in me is faithful to complete it! Jesus is the author and finisher of my faith. It wasn't too late for Abraham, Peter, Sarah, or Rahab the harlot. We're not too discouraged, too broken, or too sick to be healed.

OK, enough of those limiting thoughts that we all have faced at times in our entrepreneurial journey.

I have a few questions for you....

Are you praying and believing for the Lord to direct your steps, your family, and your business? Are you believing and expecting divine appointments in your business? Believe for divine appointments. Let His appointments and schedule become yours. He can open doors you can't open in the natural and doors that no man can shut.

Are you believing for Divine solutions?

Are you believing for Divine favor?

Are you believing for Divine results?

His results multiply. A lot of us say, Lord, you're in control, but we are still in control. We have to surrender and truly make Him Lord of our lives.

We are not just here this afternoon talking about money. Prosperity in the Bible is not just money folks. It means nothing lacking, wholeness, and abundance.

OK, just about now, if we were not on moderator mode, I could hear Joe is Ohio shouting to his wife, Susan (fictional couple of course), I thought this was going to be a business call. You bet it is. We have the proper priorities of God, Family, Health and Business, in that order. The marketplace is a ministry and we are to go into all the world and preach the Good News to everyone. Preach means to announce and we are to be the bearer of Good News wherever we are at, amen?

I have been in this entrepreneurial mentoring journey for several years now and some of my successes and failures, over the past 20 years in corporate America and in networking, are my gifts to you. They cost me dearly along the way, but it was a great investment in our success and now I am passionate about mentoring others. It was only 3 years ago, however, that I truly saw the opportunity and responsibility and co-mission that we all have in the marketplace, to share the Good News, every day of the week.

OK, let's change gears one more time and talk about how does the average person thinks about problems? The average person thinks negatively about problems and that is a reason why they are average. Wealthy people are opportunity oriented. An average person will look at a business with poor cash flow and sees a problem, the wealthy person will look for the opportunity. When people look at today's economy, they see the real estate problems or a business struggling. The entrepreneur sees the opportunities created, real estate or businesses that can be purchased, or maybe some employees that they can add to their team that they were unable to hire prior.

I hope after today you may change your viewpoint of problems. All people have problems. If you have a dream or vision, you have problems. If you have this deep seeded belief that they are negative, you will do your best trying to avoid problems. I have spent the better part of 40 years trying to avoid problems. Successful people have problems too and the more successful they are, the bigger the problems, because they have a bigger vision. The difference with successful people is they get the problem at hand solved, then go search out more problems.

Why? Because problems create opportunity and value. Think about the last time you felt incredible. Most likely, it was when you solved the last big problem you were faced with. There is an old saying that a man or woman is paid in proportion with the problems a person can solve. If you are in real estate and can only sell homes that everyone can sell, your income is limited. If you can solve problems others cannot, then you will be rewarded.

Let's look at one major challenge or problem in the Bible that we are all familiar with, the story of David and Goliath. David was young of age and small in stature taking on this huge giant. You can read the story in 1 Samuel 17. When Goliath gave his speech, everyone ran. It states everyone and that includes David. But what did David do next? David hears of the reward for the guy who takes Goliath down. Land, no taxes, he got to be a prince and you got to marry the princess. He had hope. He had a vision. Dreams are critical.

When he got turned on, he was attacked. Who put him down? His own brother. Hey, do you guys realize this is just a sheepherder? Sometimes the people closest to us, are like this about our businesses and dreams, as most people operate out of fear. And we cannot let fear stand in the way of our dreams. You will be attacked. How did David handle being attacked? Did he get all upset? He turned from him to another. It could mean that David turned to God or to some person in the crowd. He turned away from the dream stealers and you need to find people who will support your dream too and turn away from the dream stealers. What did David do next? He rehearsed. He gets to the tent and nobody was there. Everyone wants to be a prince, but there were no long lines to volunteer. A key point here is this. There is little competition at the top. Very few people are willing to pay the price. He who attempts the impossible, will have little competition. From my experience, the 80/20 rule is so overly generous. It appears to be more like 95/5 in most environments.

Goliath was the best thing that ever happened to David. Translate this to your own life. Maybe your super challenge is that you were just laid off, or your back is against the wall financially, or you are facing an impossible relationship that needs healing. Maybe you are facing cancer. What are you facing that seems impossible? Goliath brought out the best in David. David didn't take

Saul's armor. You don't have to copy someone else. You don't need their fancy education or personality or armor. You have your own gifts and strengths and the Word of God to face your Goliaths. Goliath studied his competition and the problem. David didn't study Goliath; he focused on the solution and the reward. Ask yourself if you are spending your time in analysis and studying everything to the nth degree, or are you focused on the solution and the reward. David didn't even have a sword. Goliath didn't have a chance with God on David's side.

What are you trusting in? Are you trusting in research, statistics—I'll tell you if you are trusting in statistics, you will probably never be a successful entrepreneur. Shoot when 90+ % of businesses fail, why would you if you put your trust in statistics, or what your competition is doing, or are you trusting that the Lord will direct you towards the vision He has given you.

Are you trusting in dollars; your company; your degree or education; are you trusting in the world's armor and weapons, or are you trusting in God?

We all will be afraid of different things in life. But we have to have a vision, a dream. Many adults have stopped dreaming. Or they retire and then die within 3 years of retirement, because their initial dream to retire was realized and they did not have another dream.

Here are 5 quick keys we can learn from David if you are taking notes. Again, if you would like the notes from today's call, email the person who invited you today, and they can get those to you via email by the end of the day.

Number 1....

We will all have fear at times

Have a dream

Make it a big dream—impossible dream—keep your eye on the dream, not the problem Find People who believe in you and your dream

Have Faith and take action—without action nothing happens.

David's final words. Be strong, be fearless and go do it. Go do your dreams.

When you are faced with problems and challenges, you want to speak those scriptures that advise and direct us to not fear. Here are a few.

"Fear Not"

Deuteronomy 1:21

Look, the LORD your God has set the land before you; go up and possess it, as the LORD God of your fathers has spoken to you; do not fear or be discouraged.'

Deuteronomy 3:22

You must not fear them, for the LORD your God Himself fights for you.'

Deuteronomy 31:6

Be strong and of good courage, do not fear nor be afraid of them; for the LORD your God, He is

the One who goes with you. He will not leave you nor forsake you."

Deuteronomy 31:8 And the LORD, He is the One who goes before you. He will be with you, He will not leave you nor forsake you; do not fear nor be dismayed."

## Judges 6:23

Then the LORD said to him, "Peace be with you; do not fear, you shall not die."

## 2 Kings 6:16

So he answered, "Do not fear, for those who are with us are more than those who are with them."

#### Psalm 27:3

Though an army may encamp against me, My heart shall not fear; Though war may rise against me, In this I will be confident.

#### Psalm 46:2

Therefore we will not fear, Even though the earth be removed, And though the mountains be carried into the midst of the sea:

### Psalm 56:4

In God (I will praise His word), In God I have put my trust; I will not fear. What can flesh do to me?

### Psalm 118:6

The LORD is on my side; I will not fear. What can man do to me?

## Isaiah 35:4

Say to those who are fearful-hearted, "Be strong, do not fear! Behold, your God will come with vengeance. With the recompense of God; He will come and save you."

### Isaiah 41:10

Fear not, for I am with you; Be not dismayed, for I am your God. I will strengthen you, Yes, I will help you, I will uphold you with My righteous right hand.'

#### Isaiah 44:8

Do not fear, nor be afraid; Have I not told you from that time, and declared it? You are My witnesses. Is there a God besides Me? Indeed there is no other Rock; I know not one."

### Isaiah 51:7

"Listen to Me, you who know righteousness, You people in whose heart is My law: Do not fear the reproach of men, Nor be afraid of their insults.

I have another page of scriptures and you will be able to print these with the notes, but out of the interest of time, we will not cover those on this call.

# Isaiah 54:14

In righteousness you shall be established; You shall be far from oppression, for you shall not fear; And from terror, for it shall not come near you.

## Daniel 10:12

Then he said to me, "Do not fear, Daniel, for from the first day that you set your heart to understand, and to humble yourself before your God, your words were heard; and I have come because of your words.

## Daniel 10:19

And he said, "O man greatly beloved, fear not! Peace be to you; be strong, yes, be strong!" So when he spoke to me I was strengthened, and said, "Let my lord speak, for you have strengthened me."

#### Joel 2:21

Fear not, O land; Be glad and rejoice, For the LORD has done marvelous things!

## Matthew 10:31

Do not fear therefore; you are of more value than many sparrows.

### Luke 12:7

But the very hairs of your head are all numbered. Do not fear therefore; you are of more value than many sparrows.

### Luke 12:32

"Do not fear, little flock, for it is your Father's good pleasure to give you the kingdom.

### Romans 8:15

For you did not receive the spirit of bondage again to fear, but you received the Spirit of adoption by whom we cry out, "Abba, Father."

## 2 Timothy 1:7

For God has not given us a spirit of fear, but of power and of love and of a sound mind.

## Hebrews 13:6

So we may boldly say: "The LORD is my helper; I will not fear. What can man do to me?"

#### 1 John 4:18

There is no fear in love; but perfect love casts out fear, because fear involves torment. But he who fears has not been made perfect in love.

Do you want victory? Has fear stood in the way? What are you fighting for?

Do you want to succeed? Do you want to succeed as an entrepreneur? Truly succeed?

## Yes?

Then you better be willing to do battle, get in the game, and fight like your success depends upon it -- because it does.

Don't let anyone kid you... if you want to succeed you're gonna have to fight. What's more, you'll be fighting a very formidable enemy: yourself!

Here's what I'm talking about...

Whoever you are, you have the capacity to be your own best friend -- OR -- your own worst enemy. A lot of folks will blame the enemy, but we are to take every thought captive.....and our thought life is critical.

To create serious success you must be willing to go to battle with that part of yourself that says things like:

"I can't"

"I don't want to today"

"I'm not good enough"

"I can't find the time"

"I hope this is worth it"

"why can't I do this"

"just give up"

"I'll try" get this "try" word out of your vocabulary right now. I cannot tell you how many folks share that on the phone or in person when talking about their business.

Most of these negative statements are obvious, but others like "I'll try" are more subtle, yet just as dangerous. And, make no mistake, they are all based in FEAR.

Thoughts like these WILL cross your mind... it's inevitable. It's what you do with them however that matters. You cannot fight this fight alone and that is why we have His Living Word to instruct us, guide us, and tell us who we are as a child of God.

You cannot allow these negative thoughts to persist and turn into patterns of daily thinking... it's far too destructive. It is truly a gate for the enemy.

Instead, CHALLENGE any and ALL negative thinking, and take action...

Then... move out of the "thinking phase" and into the ACTION phase. Take consistent action and implement your ideas. When you fail (and you will), make small adjustments and go at it again,

and again and again.

If you want it badly enough, exercise the mental discipline it takes to stay in action mode, doing what it takes to get to where you want to be.

Never question IF you can do it. Or IF you can make it. Make a decision that YOU WILL make it. YOU CAN do all things through Christ who strengthens you. Believe it. Then, act on that belief and continue to act on it every single day until you get there.

If you look at the most successful people in the world, what's the common denominator? Is it how they speak? Their age? Their height? Their looks? Not usually..it's what's in between their ears... it's how they think. It's the ATTITUDE they bring to the table. The ATTITUDE that says failure is not an option. That "I won't settle for "I'll Try".... but only: "I'll DO."

When you hit a wall (and you will)... find a way over that wall, around that wall or right through that wall... Do whatever it takes to get past that wall.

Be resourceful, resilient, resolute.

Monitor your self talk. Watch what you focus on. Be careful what you say to yourself. Ruthlessly examine your daily routine, and the action you take and streamline your approach so that when you're "doing business" you're doing it with maximum effectiveness and unto the Lord.

Do what others are unwilling to do, so you can achieve what others never will.

And never, ever underestimate the power of THOUGHTS ... because what you think will make you... or break you. Control your thoughts. If you don't, you can be quite certain "they" will control "you". Remember, your thoughts lead to actions, that form habits, that lead to character, that leads to success or lack thereof, but it is fruit from your thoughtlife.

I want to begin to wrap up with this as I know there are some folks on the line this afternoon facing major challenges and persecution.

What happens when your faith is on trial? When you are facing challenges and you are right in the middle of trouble and persecution? It's great to be people of faith. We all know that faith comes by hearing and hearing by the Word, but it is not saying that our faith is never going to be put to test. The Bible says this is the victory that overcomes the world even your faith. Just because the trial or persecution comes, doesn't mean it is going to rob you of your victory. We need to know how to respond when things are not seemingly going our way.

Your faith is going to be tried and will be in the middle of persecution and you will come out of it with victory. We cannot give up, cave in and quit. Faith needs to be firm in distress, afflictions, or whatever comes your way. You need to make sure you have faith before the trouble comes. What have you identified from the Word of God—this book of promises to anchor yourself when that tribulation comes or you are facing trouble. It starts by getting into the Word and looking specifically for those scriptures for what you are facing. Identify the promises from the Word.

Faith needs to be firm in the midst. Outlast it.

To suffer for a Christian means (not what most people think) it means to resist. None of us have to be nailed to a cross. Jesus' suffering was to obtain the victory. He truly suffered for us. Our part is to take the victory that He has obtained, and we are to maintain. He obtained and we are to maintain. Our job is to resist anything that is trying to rob us from that victory. We need to get in God's Word and our suffering is resisting. Where it states that By His stripes, we are healed....We are already "the healed" protecting our healing from sickness and disease. We are already "the prosperous" protecting our prosperity from anything not sound. Find the victory you already have, and our job is to resist and maintain our stance in that victory. I'm already blessed, victorious, already healed, already delivered and already prosperous and the enemy will do all he can to take that victory away from us. Stand therefore, stand there for until you get what you are standing there for. Take the time clock off God. This is what the Word says, this is what I believe, and I will not be moved.

God is faithful. We stay with the Word regardless of what report or fact comes against us. We walk by faith and not by sight. It may be a fact that you are struggling financially, but there is a difference between fact and truth. He didn't say that the fact is going to set you free, but He said the truth will set you free. The truth will set you free from the fact. There may be a fact that you have cancer, but the truth says, that by His stripes you are healed. And if you stand on that truth, the truth can make you free from that negative fact. I hope you get this. This was revelation for me. We live by faith. This is not denial....We live by truth. We call those things that be not as though they were.

I have a question for everyone on the line this afternoon. Do you believe in miracles? Do you truly believe in miracles? If you are a Christian, you HAVE TO believe in miracles. Before you think what I just said is controversial (something in our nature—probably pride resists words like "have to" or "must", or if you don't agree with that, well the virgin birth was a miracle; the resurrection was a miracle. Case closed.

So, what can stand in our way of our healing and victory in all areas of our lives?

Unbelief, doubt—we have done several trainings on this subject Unforgiveness—if you don't forgive, you will be in prison. This will stand in the way of so much

Judgment—judging others. We need to love and pray for those who attack us. Not bad people, just being used to do bad things. This can go the other way too when you see wealthy people. We judge every day. Never judge a man's harvest until you know his seed. Faith worketh by Love. If you are judging, you are not walking in love.

Strife—is there strife in your home. No peace. No power.

Pride---recognizing pride—this is an area that I have dealt with over the years and I have yet to meet an entrepreneur who has not had challenges along the way, when it comes to pride.

In closing, we need to think battleship, not cruise ship. On a battleship, every person has a critical role on the ship. God needs all of us to work together and we are not lone rangers. Too many entrepreneurs operate as such, really limiting the impact their businesses and lives can have for the kingdom. We need each other. Every joint supplieth. The key is found in two words, unity and accord. Unity means to be united as one with a single spirit, purpose, interest, or sentiment. The definition implies that individuals are bound together in oneness of heart. Accord has a similar definition. It means to be in harmony, with no one dissenting or disagreeing. If you have studied Bible history, you will know that unity (or accord) is the theme of the book of Acts. The word accord is used 11 times in Acts—a book that details the tremendous things that occurred during and after Pentecost.

When we in the Body of Christ and those in marketplace ministry begin to unite ourselves in the unity and power of God's Word and the Name of Jesus, we're going to see some supernatural things. I believe we are going to see unity in the Body of Christ that we have not seen before, and the power of God is going to be demonstrated as never before. Let us purpose in our hearts to lay aside all differences and walk in greater glory, amen.

There have been many key success factors in building our businesses over the years, but I would estimate none as important as having the expectancy that by prayer, planning and perseverance that God will provide ALL that He says He will in His living Word.

We can have that same kind of expectancy from God's Word. If God said it in His Word, the Bible, we can be sure He will keep His promise....and expectancy is something you can choose intentionally. If you have resistance when I am sharing today, work through it and hopefully this will challenge you to get into God's Word and see for yourself what promises He has for you.

I have a personal confession to share with you this afternoon and if we covered nothing more than this, it will be ALL you need. It is not something I am confessing to you to get off my chest, but something I am confessing based on who God says I am and what promises He says I have.

I set the course of my life today with my words:

I declare today that I will not be defeated, discouraged, depressed or disappointed today.

I am the head, I have insight, I have wisdom, I have ideas, I have authority.

I exercise my authority today with my words and I decree a thing and it is so.

Greater is He that is in me than he that is in the world (1 John 4:4)...the same Spirit that raised Jesus from the dead, lives in me... (Romans 8:11)

As I speak words today, they come to pass (Job 22:28); they go before me, they bring the things to pass that I desire; and they stop all attacks, assaults, oppression, and fear from coming to my life.

God is on my side today and, therefore, I cannot be defeated.

His favor surrounds me today as a shield. (Psalm 5:12). I expect favor today from heaven and from the earth.

I expect and receive favor in my home, favor in my Advantage Conferences business, favor in my ministry, favor with my finances, favor in every deal I am involved in.

I have wisdom from God today. I will think the right thoughts, say the right words and make the right decisions in every situation I face today.

My mouth speaks wisdom and my heart is filled with understanding. (Psalm 49:3)

I ask for, and receive, an abundant supply of wisdom and understanding today from God (James 1:5)...wisdom from above, wisdom that is pure, peaceable, gentle, unwavering, willing to yield, without hypocrisy. (James 3:17)

Wisdom and understanding are better than silver and gold and nothing I desire can compare with them; therefore, I make it my ambition and desire to have understanding and wisdom; therefore I know I will have all of the other desires of my heart. (Proverbs 8:10-11)

My words go before me in securing my divine health and healing...

I will not be sick today; I will not be sad today; I will not be broke today; I will not be confused today.

I have health today; I have joy today; I have all the money I need in the name of Jesus.

My steps are ordered by the Lord... (Psalm 37:23)

I have a covenant with God and by the blood of Jesus I release my divine protection and divine provision.

My angels are carrying out the Word of God on my behalf.

I receive supernatural strength and encouragement from God and my angels. (Psalm 103:20)

I expect to have divine appointments today, to run into the right people, and to be delivered from the wrong people.

Any adversity, attack, accidents and tragedies that were headed my way are diverted right now in Jesus' name.

I speak to the raging waters in my life: Peace, be still.

I say to my emotions, peace, be still.

I say to my mind, peace, be still.

I say to my body, peace, be still.

I say to my home, peace, be still.

I say to my family, peace, be still.

Now I speak to:

every mountain of fear

every mountain of discouragement

every mountain of stress

every mountain of depression

every mountain of lack and insufficiency

And I say, "Be removed and cast into the sea in Jesus' name!" (Mark 11:23) I expect the best day of my life spiritually, emotionally, relationally and financially today in Jesus' name!

I will leave you with Jeremiah 29:11-13

"For I know the plans I have for you," declares the LORD, "plans to prosper you and not to harm you, plans to give you hope and a future. Then you will call upon me and come and pray to me, and I will listen to you. You will seek me and find me when you seek me with all your heart." (Jeremiah 29:11-13)
