ATTENTION PARISHIONERS OF GRACE CHRISTIAN CHURCH, STERLING HEIGHTS, MICHICAN:

things to look for when investigating whether or not a church is crooked (or has leadership whose hearts are not in the right place):

1- what is the pastor to churchgoer ratio? are there 5 or 6 pastors for a church that has less than 150 to 200 members? that is probably a problem.

2- are the pastors related? that is definitely a problem.

3- does there seem to be a focus, or emphasis on the "prosperity gospel?" are members asked to "give until it hurts" or to "test God by giving?" this kind of teaching treats God as if He is a supernatural slot machine... be careful... it is un-Biblical to say the least. Be weary of repeated references to Malachi 3:10.

4- does there seem to be a perpetual Building Fund? is there a lot of talk about building a new church and that "more people will be reached if we had a newer/bigger facility." if that is the case, there is a problem.

5- how extensive is the Missions ministry at your church? is it limited to church leadership taking tourist trips to Israel? if so that is a problem. is mission work practiced in the local community? how extensively? by the church leadership? if not, that is something to look into and find out why more resources are not allocated to such things, as that is essentially the Mission that Christ gave us.

6- are there frequent guest speakers in which "gifts" or "love offerings" are asked for or requested? if so, this is a serious problem. I recommend you contact the IRS to be sure that this is being handled properly. This is a common problem with family operated churches... many of these pastors speak at eachothers churches regionally and get "paid" via these offerings. if they are not claimed, then the pastor, as well as the hosting pastor, is involved in tax evasion.

7- how transparent are the finances of the church? is there only one annual budget meeting held (off-hours) per year? if so, that is a problem. the finances (as well as the personal tax returns for any salaried pastors) should be available to any church member at little to no notice. if you ask to see the finances (not simply the weekly collections update which is of course printed weekly on the bulletin) and are told that you are more than welcome to come to the annual elder meeting or something like that, rather than simply getting access to the audited financials (as well as YTD interims), then something is most likely being hidden. Also, the pastors personal tax returns should be accessible upon request... look for gifts to make sure they are being claimed. if this request is denied, the pastor is hiding something.... this is a serious problem. Again, an inquiry to the IRS would help to clarify pastoral abuse of funds. (also, church leadership should have nothing to hide with regards to this and an IRS audit should be welcomed if there is no funny business going on).

8- another reason to be sure to inspect the audited financials of the church is to find out what the actual salary of the pastor is. for example, a \$50,000 salary may be agreed upon by the elders (if these people are family members... more problems!), yet he (the pastor) has access to a "discretionary fund" of \$45,000 as well.... thta is a problem. think about it, if that is the case, this pastors salary is actually \$95,000... which no reasonable pastor would ever expect, or desire to make that much money. If you

find that your pastor has a discretionary account set-up like this, watch out. He is dishonest. contact the IRS immediately for a full investigation to take place. (this may be legal technically, but there are loopholes involved that can be exploited... plus, just because it is "legal" doesn't make it inherently (or morally) right... especially for a pastor).

9- what kind of car does the pastor drive? inspect the financials of the church to verify allowances and try to determine if they are being abused. does EACH pastor get a car? if so this is a problem.... ESPECIALLY if the pastors are husband/wife. that is excessive. there is no need for the pastor to get new cars every 3 or 4 years... this is abuse and not godly stewardship of funds. the car allowance should allow for a reasonable car, there is no need for an SUV, or a truck, etc. for the church to spend more than \$15,000 for a car for the pastor is abuse. many pastors will forego the car allowance and utilize it for a Van to drive elderly or sick parishioners to church each week. this is fine and commendable.. as it saves the church funds that can be used for further outreach.

10- investigate the housing allowance. is it reasonable? this type of abuse is very common in family-run churches (as is the auto allowance discussed above). how many bedrooms does the pastor's house have? does it make sense relative to the size of the family? (i.e., if the pastors are just a husband and wife, do they need a 4 or 5 bedroom house?) how many pastors are in "church owned" houses, or receive assistance of this type? to be safe, it is probably worth contacting the IRS to conduct a thorough investigation.

There are many other things, but space is limited here. In sum, be cognizant of the transparency. in a church that is overseen by open and honest people, the above enquiries would be welcome and respected, and met with an appointment (within 24 to 48 hours of the initial request, anything longer than that means books are being cooked) to sit down with the finance dept of the church. if this type of information is difficult to get your hands on.... then there is definitely a problem and the church is most likely being run by crooks.
