The IRS told a pastor that the love offerings given to him by members of the church were taxable. In disagreement, he sued the IRS in tax court stating that they were voluntary gifts given by members of the church. The tax court disputed with the pastor stating that the members were motivated to give the love offerings because they believed him to be a good minister and they wanted him to be rewarded. While the court agreed that gifts are not taxable, it also ruled that when a love offering is given to a minister by a church member because the church member is motivated by his/her leadership or services as a minister, then that love offering is not a gift, but rather, compensation that is taxable.

This is a case where members gave pass through gifts directly to the pastor because they loved him and wanted to reward him for the work he was doing in the church and for them. The tax court ruled that even if the members wanted him to receive it as a gift, it cannot be ruled as a gift because of his relationship with the members as a minister of the gospel.
