in my estimation, a pastor's motives *should* be questioned when they appear to be living a luxurious lifestyle... its simply being responsible to do so. if a pastor is driving a mercedes, then i think that is a problem (even if it was a "gift").... or if a pastor and his family are living in a giant 5 bedroom, 3500 sq foot house when they are empty nesters or only have 1 or 2 kids.... that seems excessive to me.

i am not saying that pastors or ministers shouldnt have nice things, there is nothing wrong with nice things, but there is a difference between necessity and extravagance in my book... especially when it involves church *****, like housing and car allowances... these are easy IRS loopholes to take advantage of if they go unchecked... and it is easy for ministers at churches to abuse these benefits because many church goers are afraid or intimidated to speak up and voice their opinion.
