Eligible Donees Generally Not Listed in Publication 78

Some entities eligible to receive tax deductible charitable contributions may not be listed in Publication 78.

Churches and certain affiliated organizations

Publication 78 is based on information received in applications seeking recognition of exemption under Internal Revenue Code section 501(c)(3). **Churches, their integrated auxiliaries, and public charities** whose annual gross receipts are normally less than \$5,000 may be treated as tax-exempt without filing an application. Thus, they may not be listed in Publication 78.

That is from the IRS and why I didn't examine the churches listed. Now here are some of the problems. An attorney from Quatloos looked at some of these and concluded they were not legitimate. If they are not listed the donor may not be able to deduct said donations. The recipient may not have tax-exempt status. Promoting donations to what may be non-existent charities is misleading and could be considered fraud or misrepresentation. These unlisted charities do not have a website where one can see where the money is going and the percentages for how the money is spent. There is no oversight or accountability as one would hope to see with a registered legitimate organization.

If we are overrun with multi-millionaires, accountants, lawyers, MBAs and upper echelon movers and shakers, then why aren't we seeing the charities listed correctly? Why wasn't your friend given help setting up a foundation so that they could have tax-exempt status. If it is tax-exempt couldn't one of these movers and shakers set up a simple webpage so the information would be public and folks could find it to make donations. We give to a small registered online charity by check every Christmas because we found them and were very pleased with what they do. The group does not have the capability to accept donations online, but we can go to their very simple informative webpage.

If there have been donations of 2 grand, as laughable as that is when we keep hearing of these millionaires all around, that is great. A legitimate company, however has a responsibility to provide an honest accounting on their website and the IRS will catch them trying to take phony deductions. We also have to wonder if we can't find these charities where the money is actually going. We have seen dummy corporations siphoning money. What are these mysterious charities doing?

So, what's the verdict? We need a lot more information. If Timmy is surrounded by all these

millionaires and AC gets 3 grand for each attendee then these donations should be much larger. When families like ours are giving almost 2 grand yearly AC and these millionaires could sure do a lot more. If all this service for the Kingdom is happening this is little evidence of it. Folks could take their 10 grand and really benefit a legitimate worthwhile charity.
