\$64 Million Verdict on Sun Country Travel

Falsely claimed BBB membership

Dallas, TX, June 14, 2006 - On June 6, 2006, a jury in Dallas County returned a verdict against Sun Country Travel calling for civil penalties and restitution totaling \$64 million. The Texas Attorney General filed suit in February, 2003, alleging the company used deceptive sales and advertising practices, including misrepresenting that the company was "in good standing" with the Better Business Bureau and was endorsed by the Texas Attorney General.

In fact, when Sun Country Travel made the claim about being "in good standing" with the Bureau, the company had an unsatisfactory record with the BBB due to failure to respond to one or more customer complaints and two or more unresolved complaints.

The jury verdict also found that Sun Country Travel continued to call consumers who chose to be on the state and federal Do-Not-Call lists.

The BBB warned in alerts about Sun Country Travel in 2002 and 2003 that the company sold travel club memberships for up to \$7,000 by calling consumers and offering a "free vacation" for attending a sales presentation. In fact, the "free vacation" was a vacation certificate, requiring additional payments and other restrictions. The company had locations in Carrollton, Arlington, and Houston.

Complaints filed with the BBB alleged:

High pressure to join;

Misrepresentation of the vacation certificates and club benefits; and

Misrepresentation of the company's record with the BBB.

Some customers said Sun Country Travel was displaying a BBB report in sales presentations, and others said the company was claiming the company had "a good record" with the BBB.

In 2001 and again in 2002, the BBB in Dallas cautioned Sun Country Travel against unauthorized use of the BBB report in sales presentations. In September, 2002, the BBB in Dallas wrote to the company that "any reference to actual or implied Bureau membership by Sun Country Travel cannot be permitted."

Following the Texas Attorney General's lawsuit in February, 2003, an Agreed Temporary Injunction was issued in March, 2003. Among other things, the company was prohibited from misrepresenting that the company was a member in good standing with the BBB or had a satisfactory record with the BBB.

Under BBB policy, Better Business Bureau reports are not to be used for sales or promotion purposes. Both the voluntary BBB Code of Advertising and the Texas Deceptive Trade Practices Act prohibit misleading statements in advertising about endorsements or affiliations
