This new rule focuses on financial "disclosure." Pyramid Scheme Alert recommends three key "disclosure" requirements on MLM schemes. You can cut and paste these into the FTC form (<a href="https://secure.commentworks.com/ftc-bizopNPR/">https://secure.commentworks.com/ftc-bizopNPR/</a>) and then add your own experiences and thoughts.

- 1. All multi-level marketing companies must comply with earningsclaims disclosure rules. No multi-level marketing company should be given an option of making "no earnings claims".
- 2. Multi-level marketing companies must disclose the average retailbased income earned by participants in each level of the hierarchy.
- 3. Income disclosures of multi-level marketing companies must include:
- -- The total number of all participants who joined in the past year, not just the so-called "active participants" in one part of a year.

-- The average NET, not gross, income of participants in each level. Average net income is the average of all monies received from the company by participants minus the average of all moneys paid to the company by participants in each level. Expenditures paid to the company include product purchases, renewal fees, shipping costs, books, audio and video tapes, training and motivation seminars, computer fees, etc.

These recommendations would curb the massive deception about "unlimited income." They would expose MLMs that are based on pyramid recruiting not retail selling. Such recruitment scams are only disguised as "direct selling" businesses. And they would expose the deceptions of "average income" that exclude business costs and other fees that the schemes get from recruits. When these COSTS are added, more than 99% of all MLM recruits lose money!
