Two Plead Guilty in Offshore Bank Scam

PORTLAND, Ore. (AP) - A man and woman have pleaded guilty to fraud in an offshore bank scam in Grenada that may have cost investors more than \$125 million, federal prosecutors said.

Robert Skirving and Rita Regale each pleaded guilty to one count of conspiracy to commit money laundering in a scam involving the First International Bank of Grenada and various subsidiaries.

Both Skirving and Regale agreed in their pleas that the total funds laundered during the scheme exceeded \$100 million, and that restitution owed could exceed \$125 million, prosecutors said Wednesday.

Skirving and Regale faced maximum sentences of up to 10 years in prison, fines of \$250,000, and three years on probation.

Under his plea agreement, Skirving will receive eight years while Regale's plea agreement calls for about five to six years in prison.

Sentencing for Skirving is set for Oct. 2 before U.S. District Judge Garr King. Regale's sentencing was postponed pending trial of the remaining co-defendants.

The man accused of leading the scam, Gilbert Ziegler, also known as Van Arthur Brink, died last December, resulting in the dismissal of charges against him.

Ziegler was a former suburban Portland mortgage broker and minister who declared bankruptcy in 1994 and left the state. He established an offshore bank on the Pacific atoll of Nauru before he founded the First International Bank of Grenada in 1997, according to court records.

Ziegler was indicted by a federal grand jury in Portland in July 2002 and arrested in Uganda in June 2004 following a shootout that left a security guard dead. The indictment accused him of

soliciting investors through church groups, get-rich-quick seminars and the Internet.

Among other things, the defendants in the scam were accused of buying luxury homes in Oregon, Nevada and Grenada, along with a palace in Uganda.

Two other defendants, Douglas Ferguson and Laurent Barnabe, are scheduled for trial in February.

Gilbert Allen Ziegler, a.k.a. Van Arthur Brink (First International Bank of Grenada)

Libel Action: CASE DISMISSED

Outcome: Group went into liquidation in January, 2001 and Brink fled to Uganda. In January, 2004, a federal court in Oregon unsealed a criminal indictment against him and four other FIBG insiders who have been charged with multiple counts of fraud and money laundering. Three, Robert Skirving, Larry Barnabe and Rita Regale, were arrested in the USA and two, Van Brink and Doug Ferguson, were arrested in a shoot-out in Uganda in which one of their bodyguards was killed.

Founding Chairman and CEO of the First International Bank of Grenada, which collapsed in the summer of 2000 with losses estimated at more than \$200 million. FIBG promised annual interest rates of up to 250 per cent and claimed that deposits were insured by a sham insurer known as IDIC. The bank was famously capitalized by a letter of appraisal for a \$20 million ruby that it did not own.

Like many white-collar crooks, Ziegler specializes in ripping off the elderly and the religious and appears to have no conscience about doing so. Promotional literature distributed by FIBG was replete with Biblical references and Ziegler liked to refer to his bank as a "vision" and a "blessing". After leaving Grenada not long before FIBG stopped operating, Ziegler went to live in Uganda, where he set up similar sham operations, got married to a Ugandan woman half his age (the man with the white beard in the background is IDIC principal and fellow crook Doug Ferguson, of Canada) and bought himself luxury properties.

Ziegler is a former bankrupt who hails from Oregon. He is a prodigious writer of extraordinarily lengthy and boring e-mails in which he is fond of claiming that FIBG was actually a huge success and has billions of dollars in assets, notwithstanding the fact that it is in liquidation, its assets have disappeared and depositors are unlikely to recover any of their investment.

After being exposed by Offshore Alert in January, 1999, FIBG, the World Investors' Stock Exchange and IDIC hired one of Florida's biggest and most expensive law firms, Tampa-based

Stearns Weaver Miller Weissler Alhadeff & Sitterson, and sought an injunction at Federal Court in Miami to prevent further publication of damaging articles and also sued for libel. The Plaintiffs were not granted a hearing on the injunction application and the libel action was dismissed a year later. They also issued a press release, which, as events subsequently showed, turned out to be littered with lies.

An analysis of the hard-drive of Ziegler's computer in Grenada by investigators showed that most of the links on his Internet web browser were pointed at pornography sites, rather than financial ones, although, in keeping with his inability to accept responsibility for his actions, he blamed someone else for this. Apart from his involvement with FIBG, Ziegler was also at one time an 'Ambassador at Large' for the Dominion of Melchizedek, a fake jurisdiction that exists only in cyberspace.

Ziegler likes to tell people that he changed his name to 'Van Brink' for spiritual reasons, although he has yet to explain what these are. According to sources, however, the real story is that 'Brink' was taken from the security firm 'Brink's' and 'Van' comes from the vans in which Brink's armed guards typically transfer money. You are correct in describing the "cult-like experience" and I would also agree that some of the MLM morph into cults. But there is a difference in tactics and use of the honest and real spiritual experiences for profit. Scientology has a cult like structure that builds on control and mental processing. It really doesn't tap into the power of legitimate faith in God. Amway is different. Althought the "script" is not explicit as it is in AC, the experiences of many attendees is nothing short of spiritual. Some weep and tremble as they would at a rival.

I have no desire to get into a debate about religion per se. But the use of "religion" in MLMs is EXACTLY the same as the controlling tactics used in cults like Scientology. I would recommend that you read "Merchants of Deception" regarding how the Amway Motivational Organizations (AMOs) use cult control strategies to keep people in them.

You can see those tactics used on almost every thread on these boards. Pro=mlm posters (for the most part, there are some very few exceptions) start off by a) complaining about the fact that people dont like the company b) accuse those doing it of being losers and "just out to attack successful things" c) say that people opposing the company have not tried it and therefore don't know what they are talking about d) people opposed to mlms should not be wasting their time on a board complaining about the company e) the company is a wonderful opportunity. This is parroting the information that gets thrown at them day in and day out in motivational meetigs, CD's tapes, more motivational meetings, phone calls and so on.

I invite you to check out 5 different topics on this section of scam.com - any 5. You should be able to spot the similarities - even though all the "opportunites" are different!

I would also encourage you to read Hassan's book "Combatting cult mind control" - I should, I guess, emphasize that I am only recommending this in relation to MLMs.

Jesus Saves

Like everybody else in this country, Tailpipe wants to get rich. And like everybody else, he wants it to come fast and effortlessly. So the 'Pipe squirmed with anticipation when he found a card from a rep for Advantage Conferences (it was perched on a gas pump in West Palm Beach), promising that he could make "\$7,000 Over & Over & Over Again." How could Tailpipe resist!

The almost-clincher for the 'Pipe was the hint of divine protection the program offers. After receiving promotional materials from Mike Melvin, an Advantage Conferences emissary, the 'Pipe learned that it was a "Christ-centered business." This battered auto part wouldn't be dealing with just the hurly-burly of capitalist schemers but with an enterprise bathed in a warm, heavenly glow. All Tailpipe needed to do was ante up \$10,059.90.

Based in Allen, Texas, Advantage Conferences recruits "pro reps" across the country to sell its \$10,000 product, a ticket to a two-day "Millionaire Mindset Conference." That's a golden ticket. With each one you sell, you get a \$7,000 commission.

You don't even have to buy the first ticket yourself, the company's promotional materials say; the only cost to participate and represent the company is a \$59.95 "enrollment fee." Of course, you don't get the full \$7,000 commission unless you cough up ten grand of your own money. But, hey, it's a breeze. There are already pro reps all over Florida, from Loxahatchee to Tampa to Boca Raton, who are so eager to add you to their ranks that they're leaving business cards in odd public places.

"Nobody knows about this company," says Melvin, Tailpipe's own pro rep, who declined to answer questions about his income, saying that success depends entirely on personal effort and marketing skill. The company has grown from 220 people last November to 500 today, he says.

"As it grows out, it's going to go faster," Melvin says.

You betcha. The promotional materials talk about the "infinite width" and "infinite depth" of its potential to make money, guaranteeing that it is "legal" and "federally trademarked." The visual aid the company uses is a diagram of a pyramid.

Wait a minute. This sounds familiar.

The money really starts to roll in when the folks you recruit start to recruit some candidates of their own. Advantage Conferences is run by Tim Darnell, who writes on the company's website: "You get 100% of 70% of the two training sales of everyone who comes into your business, ad infinitum." Could this be a Jesus Christ-endorsed pyramid scheme?

Darnell apparently learned the ropes of this kind of financing at Liberty League International (formerly called Big Ass Britches Holdings, LLC, according to Arizona corporation records), which sells conferences and a "multimedia personal development program" for huge fees.

Darnell left Liberty League in 2003, got Jesus' backing, and started Advantage Conferences. In May of this year, Arizona's attorney general fined Liberty League \$115,000 for "tricking" consumers. Though Liberty League suggests that associates who hawk its products will earn sizable commissions, the attorney general's office found that a "majority of participants did not earn enough to cover the amount they paid to buy the products sold to them."

When the Dallas Better Business Bureau suggested last fall that Advantage Conferences might be a pyramid scheme, Darnell sued them for "defamation and business disparagement." A year later, the suit is still under way. The Florida attorney general's office hasn't received any complaints about Advantage, though if things proceed as such endeavors do, it may be only a matter of time. Consumer affairs experts say that, as would-be investors get wise to what's going on, pyramids inevitably collapse, with the pro reps at the bottom losing their own \$10,000 investment.

Become a Christian entrepreneur today — Tim Darnell and Mike Melvin will thank you. The 'Pipe said thanks, JC, but no thanks.
