But quite frankly, if I didn't own my own business and want to improve it and capitalize on the success of non-professional millionaire speakers, I sure wouldn't sink \$10k into this to be **my** business. It's way to risky and the chances of success are slim to none.

Consequently, and I guess I'm beginning to answer my own question, if people are being pressured into buying this conference and fed 'riches and glory' lines by the 'mentors' then they have to know the stats and they have to know that 95%+ will not make money in this. Full disclosure, etc.

I guess it's just hard for me to imagine that someone would be dumb enough to include their home address in their literature if they were pulling a scam.

That now leads me to the conclusion that Darnell and Weinzierl must be blinded by their own ambition and not privvy to the plight of their down lines. They have come to believe their spiel. They also assume that anyone could do what they do. Not so. 95%+ proves it.

Personally, if I was advising them and they have no outside sales to non-reps, I'd tell them to find a new product line that will not have them ending up in jail.

That is followed by yet another full page ad that is for a local Christian family friendly concert that will get no bang for its buck advertising in *Givers*.

Conference speaker Merri-Jo Hillaker gets pages 14-15 devoted to her with more AC plugs thrown in. 16-17 feature a write up about the Gideons International and the value of bibles in hotel rooms. John Pyke has a full page testimonial plugging his AC business. Pages 17-18 discuss the 26 Traits of Leaders. Page 18 has a half page ad for a Christian charity that will again have wasted advertising dollars.

Jack is on pages 21-22 with the <http://www.advantage-conferences-tra...-treasure.html> Save yourself 6 bucks and read it here for free.

Tim blathers on page 23 about the power of 8. Don't give 2% go the next 8 and give that full tithe of 10% he asks. On page 24 we see one half page ad for Christian apartment living and a tiny ad for a ski lodge in CO. Several small ads begging folks to call Judy and buy more ads are also on that page. The back inside cover has a huge plug for folks to become AC reps and make the big bucks. The back glossy cover is a plug for the King's Conference.

So, it is really just a big plug for AC and is in no way a Christian magazine that will provide any return on folks advertising dollars.
