**AMENDED MOTION FOR CONTINUANCE**

TO THE HONORABLE JUDGE OF SAID COURT:

**NOW COMES** Heather Dobrott, Plaintiff in the above entitled and numbered cause, who files this motion in order to respectfully request that the Court grant a continuance of the trial date set for September 19, 2011

1. I filed the above entitled action on October 20, 2010.

2. On November 18, 2010 our longtime house guest and former employee of Mr. Timothy Darnell at Advantage Conferences, Judy Sterling, took her own life. My family, as I assume was true for Mr. Darnell's family as well, was deeply affected by this tragic loss. Ms. Sterling had no family left and had been living with us as she had come out of Advantage Conferences bankrupt and simply had nowhere else to go.


3. As I had informed the court, when the dismissal hearing was scheduled on February 18, 2011, I was at Children's Medical Center with my son who has ongoing health concerns including Eosinophilic Esophagitis. His health problems have been my primary concern this year.

4. Discovery is supposed to be completed 30 days before trial and that will not be possible at this point.

5. The Allen Police had a great deal of difficulty getting responses to subpoenas and I expect that will be a concern as well.

6. The responses received by service providers are likely to require further subpoenas to other providers for related things such as e-mail accounts and payments processors etc. So, the discovery process could take several months to complete.
7. Defendant Darnell's continued postings under his own name on several sites in February 2011 which necessitated that I file a First Amended Original Petition on May 13, 2011 at which time Discovery and Interrogatory requests were served personally on Defendant Darnell.
8. I would respectfully request that the trial date be set for spring of 2012 on a date to be determined.
9. I also ask that the court order for mediation reflect a date in February 2012 when discovery is likely to be completed so that mediation can be more productive.
10. This motion is not made for purposes of delay, but so that justice may be done.



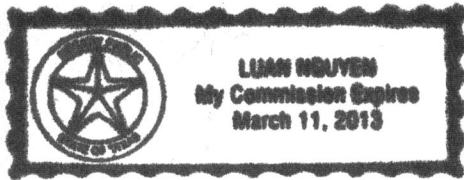



**Affidavit**

BEFORE ME, the undersigned authority, on this day personally appeared Heather Dobrott, who being by me duly sworn, on her oath stated:

1. My name is Heather Dobrott. I am over the age of twenty-one (21), of sound mind, and am fully competent to make this Affidavit. The statements contained herein are within my personal knowledge derived from my personal experience with and/or relating to Timothy S. Darnell, Advantage Conferences and other members of Advantage Conferences as described below in this Affidavit and those statements contained herein are true and correct.
2. I have spent the last few years researching pyramid schemes that were disguised as legitimate multi-level marketing businesses. I learned of Advantage Conferences'

lawsuit against the Better Business Bureau of Dallas and discussed it with other interested individuals on several online forums. After the BBB triumphed in Summary Judgment in September 2006, I purchased and published copies of pertinent court records related to that. The crux of the discussions is reflected in a passage from the BBB's Summary Judgment Motion:

“The BBB membership standards require...truth and honesty in advertising and selling practices...The (BBB) website raised concerns about AC's business model and the truthfulness of its advertising. Specifically, the BBB questions AC's use of certain trademarks and copyrights found on its website, its earning representations and whether AC was primarily engaged in promoting a pyramid scheme.” Judge Mary Murphy granted the motion in all respects and those adjudicated issues became the fodder for much heated discussion.

3. Defendant Darnell, apparently upset that his frivolous suit's documents had been published, that I had befriended an elderly rep and paid her attorney's fees so that she could file suit in Collin County District Court, and that I had expressed my opinion on the matters sued me for defamation, business disparagement, libel and seeking a permanent injunction in June 2008. As happened in the BBB case, I triumphed in Summary Judgment as well in 2009 and Darnell was denied any form of injunction.
4. Through my extensive research and blogging I became acquainted with many victims of Defendant Darnell's scam. One of them was the elderly representative of

- Advantage Conferences that we hired the attorney for so she could recover her losses. That suit in Collin County filed against Tim Darnell, Advantage Conferences and Jack Weinzierl in December 2007 ran up over \$80,000.00 in legal fees. I had no alternative, but to step in as the lead plaintiff in her stead in June of 2010.
5. In the summer of 2007 our family became very close to another former member of Advantage Conferences. Judy Sterling was a representative for Defendant Darnell's Advantage Conferences, a representative for his bogus stranger owned life insurance program, Hidden Treasures (which never paid out a dime), and the head of sales for Darnell's one issue Givers Magazine. Her losses in Advantage Conferences and the related activities landed her in chapter 7 bankruptcy. Our family helped her out financially from 2007 on and she and I became best friends. When she was about to end up homeless in July 2010 we invited her to live with our family. As she was destitute and her only child had broken off contact due to her involvement with the Advantage Conferences scam, Judy took her own life on November 18, 2010. Our family was absolutely devastated by her loss as we had come to think of her as a part of our family. We were left to handle her estate. That left me unable to pursue this case that had been filed on October 20, 2010.
6. Apparently in retaliation for blogging about Advantage Conferences and reaching out to the representatives that Darnell harmed, Defendant Darnell fabricated allegations of me sending death threats and stalking him, his family and the family of his top representative, Jack Weinzierl. Exhibit A shows the statements he admitted in court at the first hearing in the frivolous harassment suit he filed against me and

lost that he was responsible for. That was all litigated in the frivolous suit he lost in Summary Judgment. My family lives in fear because of those false criminal allegations of me stalking them and sending death threats. I turned myself in to the Allen, TX police. That report is attached as Exhibit B.

7. While Darnell was losing his suit against me in district court in Dallas. Very frightening and threatening posts started to appear on the website I moderated for at the time, Scam.com. The postings were so egregious that my attorneys sent Defendant Darnell's attorney an e-mail and warned him that those postings would have to stop immediately or discovery would be conducted and the matter turned over to the Dallas District Attorney's office for prosecution. The posts and resultant e-mail are attached as Exhibit C. Not surprisingly after Darnell was so informed the posts abruptly ceased.
8. The posts on the slam site against me, [www.heatherdobrott.com](http://www.heatherdobrott.com) were quite active from September 2009 until April 2010. At that time Judge John Roach ordered that all the e-mails between me and Plaintiff Zena Karelin in the Collin County case (where my family paid the legal fees) be turned in for review in camera. The clerk mistakenly filed my Affidavit explaining why the e-mails should not be turned over to the defense attorney. The defense attorney got a copy of the Affidavit and tipped off Defendant Darnell that the Allen , TX police were investigating three felony counts against him for [www.heatherdobrott.com](http://www.heatherdobrott.com) and two related Twitter accounts using my real name. Not surprisingly the postings ceased. Almost a year later in

February 2011 the postings started up again, and have been very sporadic in nature, but alarmingly have included pornographic material.

9. When a dismissal hearing for this case was scheduled on February 18, 2011, I was in the emergency room at Children's Medical Center with my ten year old son. He has severe allergies, eosinophilic esophagitis, and urological issues that are ongoing and much of my time is focused on caring for him.
10. Defendant Darnell's libelous postings continued in February 2011. Darnell wrote on his page on [www.mylinkingpowerforum.com](http://www.mylinkingpowerforum.com) that Plaintiff was "mentally challenged" and knew how to "damage hundreds of peoples' businesses lives, and reputations"
11. I contacted the site owner for [www.mylinkingpowerform.com](http://www.mylinkingpowerform.com), Vincent Wright via e-mail and alerted him to the fact that I found the posts made on the site he owns and manages objectionable. Wright responded by making posts on various online forums publically accusing me of "trolling." I never posted on Vincent Wright's site where Darnell had made his postings. I went to Wright only privately in an e-mail. Darnell and Wright e-mailed back and forth and spoke. Consequently, I had to deal with 3 bogus police reports filed by Vincent Wright. The Richardson police called and upset an elderly relative and then realizing the report was bogus destroyed it. The Garland Police received a complaint of a disturbance and told Mr. Wright that that they could not help him.
12. Darnell also made very troubling posts on his personal blog [www.timdarnell.org](http://www.timdarnell.org). Darnell described Plaintiff as a "neurotic individual" who had nothing better to do



“than spend their waking hours slandering your good name, or your business’s public image.” Darnell also posted about Plaintiff on Twitter claiming he had suffered “5 years of cyber attacks” and that said “damages lead to discovery.”

Darnell’s postings declare my statements about him and his business were libelous and slanderous when they were in fact all true. All my postings through early 2009 were fully and fairly litigated.

13. Due to the continued postings and bogus police reports he encouraged Vincent Wright to file, I felt I had no choice but to file an amended petition and I did so on May 13, 2011. At that time Mr. Darnell was served formal discovery requests and interrogatories personally.
14. On July 13, 2011 I sent Darnell an email advising him that I would be seeking a Continuance and e-mailed him a copy of the Motion for Continuance I intended to file. I asked that we agree to postpone mediation until discovery was closer to completion as I felt that would be advisable.
15. On July 14, 2011 I sent Darnell a copy of a Motion to Compel and asked that he work with me to get the discovery completed in a timely manner and without having to ask the Court to intervene.
16. The one and only response I got was on July 15, 2011. He said, “I am in NY – will review next week.”
17. I sent more e-mails reminding the Defendant about the Motions to Compel and for Continuance on July 18, 2011 and July 20, 2011 with the motions attached.
18. On July 22, 2011 I filed the Motion for Continuance.

19. I sent yet another reminder e-mail on July 25, 2011 about the need to get discovery issues resolved with the motion attached and got no response.
20. On July 29, 2011 I filed the Motion to Compel Discovery and Interrogatory Responses.

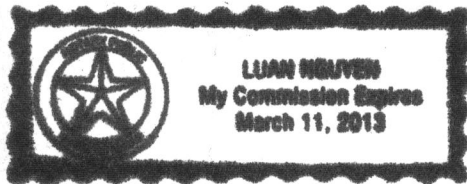



*The law requires any person who believes that a child, or person 65 years or older, or an adult with disabilities is being abused, neglected, or exploited to report the circumstances to DFPS. **A person making a report is immune from civil or criminal liability provided they make the report in good faith, and the name of the person making the report is kept confidential. Any person suspecting abuse and not reporting it can be held liable for a Class B misdemeanor.***

*Time frames for investigating reports are based on severity of allegations. Reporting suspected child abuse makes it possible for a family to get help.*

FAMILY CODE  
SUBTITLE E. PROTECTION OF THE CHILD

CHAPTER 261. INVESTIGATION OF REPORT OF CHILD ABUSE OR NEGLECT  
SUBCHAPTER A. GENERAL PROVISIONS

§ 261.001. **DEFINITIONS.** *In this chapter: (1) "Abuse" includes the following acts or omissions by a person: (A) mental or emotional injury to a child that results in an observable and material impairment in the child's growth, development, or psychological functioning; (B) causing or permitting the child to be in a situation in which the child sustains a mental or emotional injury that results in an observable and material impairment in the child's growth, development, or psychological functioning; (C) physical injury that results in substantial harm to the child, or the genuine threat of substantial harm from physical injury to the child, including an injury that is at variance with the history or explanation given and excluding an accident or reasonable discipline by a parent, guardian, or managing or possessory conservator that does not expose the child to a substantial risk of harm; (D) failure to make a reasonable effort to prevent an action by another person that results in physical injury that results in*

*substantial harm to the child; (E) **sexual conduct harmful to a child's mental, emotional, or physical welfare, including conduct that constitutes the offense of continuous sexual abuse of young child or children under Section 21.02, Penal Code, indecency with a child under Section 21.11, Penal Code, sexual assault under Section 22.011, Penal Code, or aggravated sexual assault under Section 22.021, Penal Code; (F) failure to make a reasonable effort to prevent sexual conduct harmful to a child;***

*(G) compelling or encouraging the child to engage in sexual conduct as defined by Section 43.01, Penal Code; (H) causing, permitting, encouraging, engaging in, or allowing the photographing, filming, or depicting of the child if the person knew or should have known that the resulting photograph, film, or depiction of the child is obscene as defined by Section 43.21, Penal Code, or pornographic; (I) the current use by a person of a controlled substance as defined by Chapter 481, Health and Safety Code, in a manner or to the extent that the use results in physical, mental, or emotional injury to a child; (J) causing, expressly permitting, or encouraging a child to use a controlled substance as defined by Chapter 481, Health and Safety Code; or (K) causing, permitting, encouraging, engaging in, or allowing a sexual performance by a child as defined by Section 43.25, Penal Code. (2) "Department" means the Department of Family and Protective Services. (3) "Designated agency" means the agency designated by the court as responsible for the*

*protection of children. (4) **"Neglect" includes: (A) the leaving of a child in a situation where the child would be exposed to a substantial risk of physical or mental harm, without arranging for necessary care for the child,***

**and the demonstration of an intent not to return by a parent, guardian, or managing or possessory conservator of the child; (B) the following acts or omissions by a person: (i) placing a child in or failing to remove a child from a situation that a reasonable person would realize requires judgment or actions beyond the child's level of maturity, physical condition, or mental abilities and that results in bodily injury or a substantial risk of immediate harm to the child; (ii) failing to seek, obtain, or follow through with medical care for a child, with the failure resulting in or presenting a substantial risk of death, disfigurement, or bodily injury or with the failure resulting in an observable and material impairment to the growth, development, or functioning of the child; (iii) the failure to provide a child with food, clothing, or shelter necessary to sustain the life or health of the child, excluding failure caused primarily by financial inability unless relief services had been offered and refused; (iv) placing a child in or failing to remove the child from a situation in which the child would be exposed to a substantial risk of sexual conduct harmful to the child; or (v) placing a child in or failing to remove the child from a situation in which the child would be exposed to acts or omissions that constitute abuse under Subdivision (1)(E), (F), (G), (H), or (K) committed against another child; or (C) the failure by the person responsible for a child's care, custody, or welfare to permit the child to return to the child's home without arranging for the necessary care for the child after the child has been absent from the home for any reason, including having been in residential placement or having run away. (5) "Person responsible for a child's care, custody, or welfare" means a person who traditionally is responsible for a child's care, custody, or welfare, including: (A) a parent, guardian, managing or possessory conservator, or foster parent of the child; (B) a member of the child's family or household as defined by Chapter 71; (C) a**



*person with whom the child's parent cohabits; (D) school personnel or a volunteer at the child's school; or (E) personnel or a volunteer at a public or private child-care facility that provides services for the child or at a public or private residential institution or facility where the child resides.*

## **INTERNET LAWS**

Since 1996, Congress has passed several laws that address sexually explicit materials and sexual predation found on the Internet, including:

- The Communications Decency Act (CDA): Passed in 1996, the CDA represents Congress's first attempt to regulate children's access to sexually explicit material on the Internet. The CDA made it illegal to put "indecent" content on the Internet where kids could find it. However, the Supreme Court unanimously declared the CDA unconstitutional in 1997 in



*Reno v. ACLU* for "broad suppression of speech addressed to adults"; the term "indecent" was found to be too vague.

- The Child Online Protection Act (COPA): In 1998 a narrower version of the CDA required commercial Web sites to verify proof of age before giving users access to sexually explicit material considered obscene for minors. COPA was immediately challenged by the ACLU and other civil liberty organizations, and in 1999 a permanent injunction was ordered against its enforcement. On May 13, 2002, in *ACLU v. Ashcroft*, the Supreme Court directed a lower court to reexamine its ruling that COPA was unconstitutional. On March 7, 2003, the court again found that COPA was unconstitutional. On June 29, 2004 the Supreme Court kept in place the 1999 lower-court ruling against the enforcement of COPA, but ordered the lower court to consider whether recent advancements in filtering technologies could protect children more or less effectively than the criminal sanctions specified in COPA.
- The Children's Internet Protection Act (CIPA): In 2000, Congress enacted CIPA, which took effect in April 2001, requiring schools and libraries receiving federal technology funds to install pornography-blocking software on their computers. The American Library Association filed suit alleging that the library portion of CIPA was unconstitutional on its face. On May 31, 2002, the U.S. District Court for the Eastern District of Pennsylvania agreed. The U.S. government appealed that decision, and on June 23, 2003, the Supreme Court overturned the district court's ruling. (The school portion of CIPA has not yet been challenged, so its constitutionality remains untested.)

Several states have tried to pass legislation that would protect children by reducing the amount of unsolicited e-mail, or spam, that comes their way.

### **Sexual Predator Laws**

Federal laws have been enacted to protect children from people who lure or attempt to lure them into an offline meeting for the purpose of performing illegal sexual acts or coercing them to provide sexually explicit photos of themselves.

In April 2003, Congress passed a law that provides wiretapping authority for seven sexual offenses, including child pornography and the sexual exploitation of children. Part of a broader child-protection bill entitled the Protect Act of 2003, which also mandates the Amber Alert system for abducted children, this law expands federal law-enforcement agencies' wiretapping authority to catch online predators before they strike.




