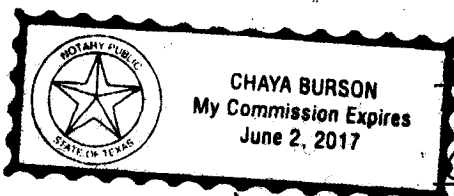
Witness, who after being duly sworn, stated:

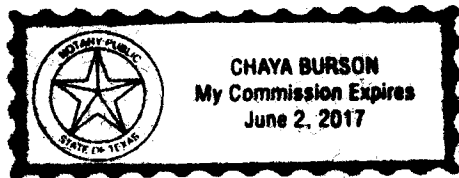
